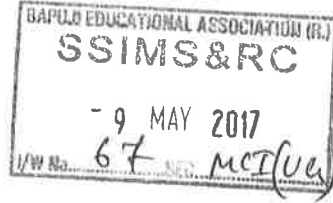

Sub. Continuance of recognition of MBBS degree granted by Rajiv Gandhi University of Health Sciences, Bangalore in respect of students being trained at S S Institute of Medical Sciences & Research Centre, Davangere.

Sir/ Madam,

I am directed to inform that the assessment of the physical and the other teaching facilities available for continuance of recognition of MBBS degree granted by Rajiv Gandhi University of Health Sciences, Bangalore in respect of students being trained at S.S. Institute of Medical Sciences & Research Centre, Davangere was carried out by the Council Assessors on 10th& 11th May, 2016. The assessment report (10th& 11th May, 2016) was considered by the Executive Committee at its meeting held on 13.05.2016. The following recommendations of the Executive Committee was approved by the General Body of the Council at its meeting held on 22nd November, 2016:-

"The Executive Committee of the Council considered the assessment report (10th& 11th May, 2016) and decided to recommend that recognition of MBBS degree granted by Rajiv Gandhi University of Health Sciences, Bangalore in respect of students being trained at S.S. Institute of Medical Sciences & Research Centre, Davangere be continued restricting the number of admission to 150 (One Hundred fifty) students.

The Executive Committee further decided that the attention of the institute be drawn to Sections 8(3)(2), 8(3)(3) & 8(3)(4) of the Establishment of Medical Colleges Regulations (Amendment), 2010 (Part II) dated 16th April 2010 and act accordingly at appropriate time, which reads as under:-

8 (3) ...

(2) The recognition so granted to an Undergraduate Course for award of MBBS degree shall be for a maximum period of 5 years, upon which it shall have to be renewed.

(3) The procedure for 'Renewal' of recognition shall be same as applicable for the award of recognition.

(4) Failure to seek timely renewal of recognition as required in sub-clause (a) supra shall invariably result in stoppage of admissions to the concerned Undergraduate Course of MBBS at the said institute."

The above decision of the General Body has been approved by the Oversight Committee on 28.04.2017.


