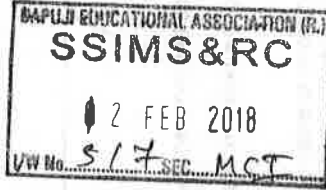

Subject: Rajiv Gandhi University of Health Sciences, Bangalore - Recognition of M.Ch(Urology/Genito-Urinary Surgery) qualification for 02 seats in respect of students being trained at S S Institute of Medical Sciences& Research Centre, Davangere.

Sir/ Madam,

I am directed to state that the Postgraduate Medical Education Committee of this Council at its meeting held on 24/01/2018 considered the Compliance Verification Assessment Report (27/11/2017) along with the Council Assessor's Report (26.07.2016) and compliance dated 19/04/2017 submitted by the college authorities on the standard of examination and other teaching facilities for Recognition of M.Ch(Urology/Genito-Urinary Surgery) qualification for 02 seats at S S Institute of Medical Sciences& Research Centre, Davangere granted by Rajiv Gandhi University of Health Sciences, Bangalore and decided as under:-

"The Postgraduate Medical Education Committee considered the Compliance Verification Assessment Report (27/11/2017) along with the Council Assessor's Report (26.07.2016) and compliance dated 19/04/2017 submitted by the college authorities and decided to recommend to the Central Government that M.Ch(Urology/Genito-Urinary Surgery) qualification for 02 seats granted by Rajiv Gandhi University of Health Sciences, Bangalore in respect of students being trained at S S Institute of Medical Sciences& Research Centre, Davangere be recognized and included in the 1st Schedule to the I.M.C. Act, 1956.

The Postgraduate Medical Education Committee further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course."

You are therefore requested to notify the above qualification at the earliest.

The above minutes of the Postgraduate Medical Education Committee have been approved by the Oversight Committee vide their letter dated 30/01/2018.
